Tamil Nadu Acts and Ordinances

The following Act of the Tamil Nadu Legislative Assembly received the assent of President on the 19th July 1994 and is hereby "published for

ACT No. 45 OF 1994.

An Act to provide for reservation of seats in educational institutions in the State and of appointments or posts in the services under the State for the Backward Classes of citizens and for persons belonging to the Scheduled Castes and the Scheduled Tribes in the State of Tamil Nadu.

WHEREAS the policy of reservation for the social, economic and educational advancement of the people belonging to Backward Classes of citizens in admissions to educational institutions in the State and for appointments in the services under the State has been under implementation in the State of Tamil Nadu for a long time;

AND WHEREAS the State of Tamil Nadu is a pioneer State in providing reservation for the underprivileged and the first communal Government Order was passed in the year 1921 and the proportional representation for communities was made in the year 1927 in the State of Temil Nadu;

AND WHEREAS a large percentage of population of Tamil Nadu suffering from social and educational backwardness for many years have started enjoying the fruits of the reservation policy and have been able to improve their lot and attain a higher standard of living;

AND WHEREAS clause (4) of Article 15 of the Constitution enables the State to make any special provision for the advancement of any socially and educationally Backward Classes of citizens or for the Scheduled Castes and the Scheduled Tribes;

AND WHEREAS clause (4) of Article 16 of the Constitution enables the State to make any provision for the reservation of appointments or posts in favour of any Backward Class of citizens which, in the opinion of the State, is not adequately represented in the services under the State;

AND WHEREAS under clause (1) of Article 38 of the Constitution, the State shall strive to promote the welfare of the people by securing and protecting effectively as it may, a social order in which justice, social, economic and political, shall inform all the institutions of the national life;

AND WHEREAS under clause (2) of Article 38 of the Constitution, the State shall, in particular, strive to minimise the inequalities in income and endeavour to eliminate inequalities in status, facilities and opportunities, not only amongst in different vocations;

AND WHEREAS under clause (b) of Article 39 of the Constitution, the State shall, in particular, direct its policy towards securing that the ownership and control of the material resources of the community are so distributed as best to subserve the

AND WHEREAS under clause (c) of Article 39 of the Constitution, the State economic system does not result in the concentration of wealth and means of production to the common detriment:

AND WHEREAS under Article 46 of the Constitution, the State shall promote, with special care, the educational and economic interests of the weaker securing of the people, and, in particular, of the Scheduled Castes and the Scheduled Tribes, and shall protect them from social mustice and all forms of exploitation;

AND WHEREAS the representatives of the various political parties and social forums representing backward classes have requested the State Government to consider all the ramifications of the Supreme Court indgment, dated the 16th day of November 1992 in Indra Sawiner Vs., Union of India (AIR. 1993 SC 477) regarding reservations under clause (4) of Article 16 of the Constitution and take steps to

AND WHEREAS in the opinion of the State Government, Backward Classes of citizens, and the persons belonging to the Scheduled Castes and the Scheduled Tribes, who constitute the majority of the total population of the State are not adequately state of Tamil Nadu;

AND WHEREAS the State Government have, after careful consideration, taken a policy decision that the existing level of sixty-nine per cent reservation in admission to educational institutions in the State and in the services under the State, for the Backward Classes of citizens and for the persons belonging to the Scheduled Castes and the Scheduled Tribes, should be continued for ensuring the advancement of the majority of the people of the State of Tamil Nadu;

BE it enacted by the Legislative Assembly of the State of Tamil Nadu in the Forty-fourth Year of the Republic of India as follows:—

Short title, extent and commencement.

- 1. (1) This Act may be called the Tamil Nadu Backward Classes, Scheduled Castes and Scheduled Tribes (Reservation of seats in Educational Institutions and of appointments or posts in the Services under the State) Act, 1993.
 - (2) It extends to the whole of the State of Tamil Nadu.
- (3) (a) Sections 2, 3, 4, 5, 6 and 8 shall be deemed to have come into force on the 16th day of November 1992.
- (b) Section 7 shall be deemed to have come into torce on the 15th day of March 1993.

Declaration.

12. It is hereby declared that this Act is for giving effect to the policy of the State towards securing the principles laid down in Part IV and in particular, in Article 38, clauses (b) and (c) of Article 39 and Article 46 of the Constitution,

Definitions.

- 3. In this Act, unless the context otherwise requires,—
- (a) "Backward Classes of citizens" means the class or classes of citizens who are socially and educationally backward, as may be notified by the Government in the Tamil Nadu Government Gazette, and includes the Most Backward Classes and the Denotified Communities;



- (b) "educational institution" means-
- (i) any college or other educational institution, maintained by the State or receiving aid out of the State funds, or affiliated to any university established by law including an university college and a constituent college; or
- nient, (ii) any institute or training centre recognised or approved by the Govern-

with the object of preparing, training or guiding its students for any certificate, degree or diploma or other academic distinctions granted or conferred by any University, or authority established or approved in this behalf by the Government;

- (c) "Government" means the State Government;
- (d) "Scheduled Castes" shall have the same meaning as in the Constitution;
- (e) "Scheduled Tribes" shall have the same meaning as in the Constitution.
- 4. (1) Notwithstanding anything contained in any judgment, decree or order of any court or other authority, having regard to the social and educational backwardness of the Backward Classes of citizens and the persons belonging to the Scheduled Castes and the Scheduled Tribes who constitute the majority of the total population of the State of Tamil Nadu, the reservation in respect of the annual permitted strength in each branch or faculty for admission into educational institutions in the State, for the Backward Classes of citizens and for the persons belonging to the Scheduled Castes and the Scheduled Tribes, shall be sixty-nine per cent.

Reservation of seats in educational institutions.

- (2) The reservation referred to in sub-section (1) shall, in respect of the persons belonging to the Backward Classes, the Most Backward Classes and Denotified Communities, the Scheduled Castes and the Scheduled Tribes, be as hereunder:—
 - (a) Backward Classes ... Thirty per cent.
 - (b) Most Backward Classes and Denotified Twenty per cent.
 Communities.
 - (c) Scheduled Castes ... Eighteen per cent.
 - (d) Scheduled Tribes ... One per cent.

5. (1) Notwithstanding anything contained in any judgment, decree or order of any court or other authority, having regard to the inadequate representation in the services under the State, of the Backward Classes of citizens and the persons belonging to the Scheduled Castes and the Scheduled Tribes, who constitute the majority of the total population of the State of Tamil Nadu, the reservation for appointments or posts in the services under the State, for the Backward Classes of citizens and for the persons belonging to the Scheduled Castes and the Scheduled Tribes, shall be sixty-nine per cent.

Explanation.—For the purposes of this Act, "services under the State" includes the services under—

- (i) the Government;
- (ii) the Legislature of the State;
- (iii) any local authority;

6. Notwithstanding anything contained in sections 4 and 5, the claims of the students or members belonging to the Backward Classes of citizens or the Scheduled Castes or the Scheduled Tribes, shall also be considered for the unreserved seats, appointments or posts which shall be filled on the basis of merit and where a student or member belonging to the Backward Classes of citizens or the Scheduled Castes or the Scheduled Tribes, is selected on the basis of merit, the number of seats, appointments or posts reserved for the Backward Classes of citizens or for the persons belonging to the Scheduled Castes or the Scheduled Tribes, as the case may be, shall not in any way be affected.

Classification of Backward Classes of citizens.

7. The Government may, from time to time, based on the reports presented at the appropriate periods to the Government by the Tamil Nadu Backward Classes Commission constituted in G.O. Ms. No. 9, Backward Classes and Most Brekward Classes Welfare Department, dated the 15th day of March 1993, by notification, classify or sub-classify the Backward Classes of citizens for the purposes of this

Power to make rules.

- 8. (1) The Government may make rules for carrying out the purposes of this
- (2) (a) All rules made under this Act shall be published in the Tamil Nudu Government Gazette and unless they are expressed to come into force on a pacticular day, shall come into force on the day on which they are so published.
- (b) All notifications issued under this Act shall, unless they are expressed to come into force on a particular day, come into force on the day on which they are published.
- (3) Every rule made or notification or order issued under this Act shall, as soon as possible, after it is made or issued, be placed on the table of the Legislative Assembly, and if, before the expiry of the session in which it is so placed or the next session, the Assembly makes any modification in any such rule or notification or order, or the Assembly decides that the rule or notification or should not be made or issued, the rule or notification or order shall thereafter have effect only in such modified form or be of no effect, as the case may be, so, however, that any such modification or annulment shall be without prejudice to the validity of anything previously done under that rule or notification or order.

9. Notwithstanding anything contained in any judgment, decree or order of any court or other authority, the reservation of sixty-nine per made, and anything done or any action taken on the basis of such reservation, by the Government for admissions into educational institutions in the State and for appointments for chosts in the services under the State, for the Backward Classes of citizens and for the persons bolonging to the Scheduled Castes and the Scheduled Tribes, during whe period commencing on the 16th day of morrowing SALEGH COLLEGE OF ENGINEERING

10. If any difficulty arises in giving effect to the provisions of this Act, the Government may, by an order published in the Tamil Nadu Government Gazette, make such provisions not inconsistent with the provisions of this Act as appear to them to be necessary or expedient for removing the difficulty:

Power to remove difficulties.

Provided that no such order shall be made after the expiry of two years from the date of the publication of this Act in the Tamil Nadu Government Gazette.

- i) Tamil Nadu candidates who have passed VIII, IX, X, XI and XII Std. from schools situated in Tamil Nadu are eligible to apply. They need not produce <u>Nativity Certificate</u> for verification.
- Tamil Nadu native candidates who have passed any of the VIII, IX, X, XI and XII Std. or their equivalent examination from schools situated outside Tamil Nadu can also apply. They should produce **Original Nativity Certificate only in electronic form/digitally signed e-Certificate** at the time of original certificates verification at TNEA Facilitation Centre (TFC).
- children of Central Government Employees may also apply for admission, irrespective of their native, provided their parents or guardians (only if both parents are not alive) have been serving in Tamil Nadu continuously for the past **FIVE YEARS** at the time of submission of application. This should be supported by producing a certificate from the employer of the parent or guardian, to that effect at the time of original certificates verification at TFC.

- Children of employees in Public Sector or Government recognised Institutions who at the time of submission of application for admission employed in Tamil Nadu continuously for the past five years may also apply irrespective of their domicile. A certificate from the employer stating that the person is a Permanent Employee of the Firm or Institution concerned with evidence like Income Tax return, PF Slips, etc. and is working in Tamil Nadu continuously for the past **FIVE YEARS** has to be produced at the time of original certificates verification at TFC.
- v) Sons and daughters of All India service Tamil Nadu cadre officers are eligible to apply. A Self declaration from the parent in this regard is to be produced at the time of original certificates verification.
- vi) Other State candidates who have studied VIII, IX, X, XI and XII Std. in Tamil Nadu are eligible to apply. They need not produce "Nativity Certificate".

Note:

- Applications without proper Nativity Certificate for Category (ii) without proper employer certificate for categories (iii) and (iv)and without self declaration from the parent for category (v) will not be considered.
- 2. Category (vi) need not produce employer certificate / nativity certificate.
- 3. Categories from (iii) to (vi) will be considered under "Open Competition".

Srilankan Tamil Refugee

As per G.O. (St) No. 172 Higher Education (J2) Dept. dated:29.06.2010 candidates who are Srilankan Tamil Refugee studied in Tamil Nadu will be considered under open competition. They have to produce the following at the time of original certificates verification at TFC:

- (i) Identification certificate from the Head Quarters Tahsildar.
- (ii) Those who have not registered in the refugee camp should produce original passport, visa and letter registered with Police Station.

Improvement marks: As per the G.O. No. 184 HE (J2) Dept. dt: 09.06.2005 and G.O. (st) No. 143 HE (J2) Dept. dt: 06.05.2008 improvement marks obtained by the candidates including Other State candidates from 2006 onwards will not be considered.

Marine Engineering Branch

The Director General of Shipping, Ministry of Shipping, Government of India, vide Notification No. II. TR (21) 97 dated: 03.10.2002 have issued notification stating that, for Marine Engineering Degree Programme the candidate should pass in 10+2 or equivalent examination with Physics (P), Chemistry (C), Mathematics (M) and English as separate subject with an average of not less than 60% in PCM. Further a minimum of 50% in English either at 10^{th} or 12^{th} standard is required for all the candidates.

Other Requirements:

- (i) Maximum age limit 25 years.
- (ii) Minimum Height 157cm.
- (iii) Minimum Weight 48kg.
- (iv) Normal Colour vision.

Before selecting the course the candidate shall ensure that they are medically fit for the course.

The candidates will be admitted only on production of physical fitness certificate obtained from the Medical Officer authorized by the Director General of Shipping, failing which they will lose the admission.

- 1.2 Seats in B. E. & B. Tech. Degree Courses in Government, Government Aided and Seats surrendered by Self-Financing Engineering Colleges.

 - (i) Seats in Government Engineering Colleges

3. ELIGIBILITY RULES

General

Candidates satisfying the eligibility conditions given below as on the last date of submission of online application are eligible to apply. Passing the qualifying examination or changing the religion after the last date of submission of online application shall not be considered.

3.1 Nativity

- Tamil Nadu candidates who have passed VIII, IX, X, XI and XII Std. in Tamil Nadu are eligible to apply.
 They need not enclose <u>Nativity Certificate</u>.
- ii) Tamil Nadu native candidates who have passed any of the VIII, IX, X, XI and XII Std. or their equivalent examination from schools situated outside Tamil Nadu can also apply. They should enclose a copy of **Nativity Certificate only in electronic form/digitally signed e-Certificate**.
- iii) Children of Central Government Employees may also apply for admission, irrespective of their native, provided their parents or guardians (only if both parents are not alive) have been serving in Tamil Nadu continuously for the past FIVE YEARS at the time of submission of application, which should be supported by enclosing a certificate from the employer of the parent or guardian, to that effect.



- iv) Children of employees in Public Sector or Government recognised Institutions who at the time of submission of application for admission employed in Tamil Nadu continuously for the past five years may also apply irrespective of their domicile. A certificate from the employer has to be enclosed along with the application stating that the person is a Permanent Employee of the Firm or Institution concerned with evidence like Income Tax return, PF Slips, etc. and is working in Tamil Nadu continuously for the past FIVE YEARS.
- v) Sons and daughters of All India service Tamil Nadu cadre officers are eligible to apply.
- vi) Other State candidates who have studied VIII, IX, X, XI and XII Std. in Tamil Nadu are eligible to apply. They need not enclose "Nativity Certificate".

Note:

- Applications without proper Nativity Certificate for Category (ii) and without proper employer certificate for categories (iii) and (iv) will not be considered.
- 2. Categories (v) and (vi) need not enclose employer certificate / nativity certificate.
- 3. Tamil Nadu native candidates alone will be considered for communal reservation i.e. categories from (iii) to (vi) will be considered under "Open Competition".

Srilankan Tamil Refugee

As per G.O. (St) No. 172 Higher Education (12) Dept. dated: 29.06.2010 candidates who are Srilankan Tamil Refugee studied in Tamil Nadu will be considered under open competition. They have to enclose the following:

- (i) Identification certificate from the Head Quarters Tahsildar.
- (ii) Those who have not registered in the refugee camp should submit a copy of passport, visa and letter registered with Police Station.

Note:

- (i) When the candidates produce grade certificates, they have to produce the actual marks also otherwise only the minimum marks applicable to the grades in the eligible subjects (Mathematics, Physics, Chemistry and Fourth Optional Subject) will be taken into account.
- (ii) For minimum eligibility rounding of marks and normalised marks will not be considered.
- **3.3 Improvement marks:** As per the G.O. No. 184 HE (J2) Dept. dt: 09.06.2005 and G.O. (st) No. 143 HE (J2) Dept. dt: 06.05.2008 improvement marks obtained by the candidates including Other State candidates from 2006 onwards will not be considered.

3.4 Marine Engineering Branch

The Director General of Shipping, Ministry of Shipping, Government of India, vide Notification No. II. TR (21) 97 dated: 03.10.2002 have issued notification stating that, for Marine Engineering Degree Programme the candidate should pass in 10+2 or equivalent examination with Physics (P), Chemistry (C), Mathematics (M) and English as separate subject with an average of not less than 60% in PCM. Further a minimum of 50% in English either at 10^{th} or 12^{th} standard is required for all the candidates.

Other Requirements:

- (i) Maximum age limit 25 years.
- (ii) Minimum Height 157 cm.
- (iii) Minimum Weight 48 kg.
- (iv) Normal Colour vision

Before selecting the course the candidate shall ensure that they are medically fit for the course.

The candidates will be admitted only on production of physical fitness certificate obtained from the Medical Officer authorised by the Director General of Shipping, failing which they will lose the admission.

3.5 Mining Engineering Branch

Note to Female candidate opting for Mining Engineering course.

(1) As per Mines Act 1952, 46 (1) no woman shall, notwithstanding anything contained in any other law, be employed –

(a) in any part of a mine which is below ground;

(b) in any mine above ground except between the hours of 6 A.M. and 7 P.M.
(2) As per Coal Mines Regulation 1957, 86 (2) no adolescent or women shall descend or ascend a shaft in a cage or other means of conveyance unless accompanied by one or more adult males.

(3) They should satisfy the academic norms of Anna University.
